MINUTES

I. Call to Order

The regular meeting of the Merced City and County Continuum of Care (CoC) was called to order at 11:05 am on February 1, 2024, via Microsoft Teams by Matt Serratto.

II. Roll Call

III. Notice to Public – Read by Merced CoC Chair, Matt Serratto

IV. Public Comment

Christy McCammond stated the City of Los Banos has posted Request for Proposal (RFP) for a Homekey co-applicant/developer. Bids are due next week. Intention is to apply as soon as the application is posted around April 28th.

V. Consent Agenda Items

Approval sought for the February 2, 2024 meeting agenda, the October 5, 2023 meeting minutes, and the November 2, 2023 meeting minutes. Motion from Steve Roussos, second from Ray Reyna. None opposed. Motion passed unanimously at 11:11 am.

VI. Community Projects

A. Merced Navigation Center

David Carr reported that the Navigation Center is currently sheltering 76 people and 14 dogs. The Navigation Center has served 816 individuals since it opened in 2021 and has housed 87.

B. Emergency Housing Vouchers

Jesenia Aguilar stated there are currently 52 housed, 13 vouchers pending approval/denial, 2 vouchers pending review, and 1 voucher applications is out with agencies in the community.

C. Distributive Housing/Unincorporated Housing

David Carr stated 24 individuals with one bed vacant. Los Banos has 20 individuals with no open beds. Served 366 since opening. Housed 59 people since opening. Unincorporated Housing has served 21 housed three. 10 in beds, two open. One more house today, six beds added making 18 beds available.

D. Homeless Court

David Carr reported that there were 40 graduates in November, 9 graduates in December and will report January's graduate numbers in the March 7, 2024 meeting.

E. Housing Developments

Maribel McCarroll reported on Homekey Application Round 3 stating that Merced County, the City of Merced, and the City of Los Banos submitted the application in July. Two out of the three applications shared a developer that will not be receiving anymore HUD grants. Third Application for Tiny Homes developer received an update that the area is over-prescribed with Homekey funds. All three applications are not predicted to receive awards. 1213 opened on Dec 1st with an Open House. Currently 48 individuals are placed. Placed individuals are being referred by Behavioral Health Recovery Services. The CoC meets with program service providers on a weekly basis and will be including the City of Merced at the next meeting.

The Outreach Committee met on September 20, 2023 and nominated Sargeez Teimoorshahi for Chair of the Outreach Committee. Motion: Steve Rousso, Second: Josh Pedrozo, Motion passed unanimously at 11:22 AM.

2. Youth Homelessness System Improvement (YHSI) Grant

The CoC sought approval and authorization to apply for and accept Youth Homeless System Improvement Grant of 1.1 million dollars. The CoC would like to create a Youth Advisory Board to structure a board and become competitive for funding. Motion: Steve Roussos, Second: Josh Pedrozo, Motion passed unanimously at 11:26 AM.

A. Regionally Coordinated Homeless Housing, Assistance and Prevention Program (HHAP) Round 5 Updates

Maribel McCarroll reported that the CoC has successfully completed the three workshops necessary to make a preliminary draft of the Regionally Coordinated Action Plan that is available online for the open feedback period. Maribel McCarroll stated the HHAP 5 will be accepting a single application that will be a combination of the CoC and Merced County by request of Cal ICH. The CoC received \$41,000.00 less in allocations, at roughly 1.1 million dollars.

B. Lived Experience Committee

Maribel McCarroll stated that the Lived Experience Committee is a mandatory committee through the CoC hub as well as CFR 57576. The CoC will be accepting volunteers by email to join the committee. A chair and a vice chair will need to be voted in.

X. Collaborative Applicant Report Out

A. Regionally Coordinated Homelessness Action Plan

See Her reported that a reminder was sent on Friday, January 26 that the feedback for the Regionally Coordinated Homelessness Action Plan is due on February 9th at 4:00 PM.

B. 2024 Point-in-Time (PIT Count)

Maribel McCarroll stated that the 2024 PIT Count was conducted by volunteers on January 25th led by Phil Schmaus and his team. At the time of the meeting, the PIT Count was concluded, and the Collaborative Applicant was in the process of scrubbing the numbers. As lead point on the shelter count, the Collaborative Applicant had contacted all shelters, distributed houses, and internal organizations that offer mental health services. PIT Count numbers are not available yet but the deadline to publish is April 24th. Draft publication for the PIT Count will be shared at the April CoC meeting.

C. Merced Continuum of Care Website

Mickayla Reyna and Maribel McCarroll presented the new aesthetic and user interface for the CoC website.

Lucia Tejeda reported that the Youth Committee did not meet in November or December. There was a committee meeting in January in addition to a meeting with Phil Schmauss regarding participation in the PIT Count. Members of the Legacy Project from The Dr. Jennifer Jones Foundation stated, at the meeting, that their last Outreach event in November was a success and may be held on a quarterly basis to drive committee recruitment. Lucia Tejeda added that the committee has learned about the Student Resiliency Center on Main St, stating that the drop-in center is open to students aged 12-18 at no charge. While they are in the exploration stages of the program, there is interest in adding activities for children aged 4-12.

D. Health

Maria Nava reported that moving forward, she would be replacing Donna Chin.

E. Faith

Margaret Simmons reported that the Faith Committee is currently meeting on a regular basis with a focus on identifying and networking with other faith-based groups.

F. Outreach

Sargeez Teimoorshahi reported that the Outreach Committee continues to meet on a bi-weekly basis in addition to quarterly pop-up events held by the Parks Department in various Merced parks to outreach to the homeless population. Sargeez Teimoorshahi also stated that the Merced Police Department and Chief are seeking resources to share with providers regarding services offered to the public.

The Merced City and County Continuum of Care (Merced CoC) is a current recipient of HHAP funding Round 1 through Round 4. California Interagency Council on Homelessness (Cal ICH) released the notice of funding availability (NOFA) Homeless Housing, Assistance and Prevention (HHAP) Program Round 5 grant funding on September 29, 2023. HHAP round 5 purpose is organizing and deploying the full array of homelessness programs and resources comprehensively and effectively, and to sustain existing federal, state, and local investments towards long-term sustainability of housing and supportive services. (HSC §§ 50232(a) and 50236(a).)

To accomplish these goals, HHAP-5 requires applicants to submit a Regionally Coordinated Homelessness Action Plan (Regional Plan) to be considered eligible for HHAP round 5 base allocations. Members are expected to conduct themselves with courtesy and respect, without harassment, physical, or verbal abuse. Personal relationships will not result in special considerations, including bias or favoritism, that influence the performance of their official duties in a manner contrary to the interest of the CoC. Members are expected to exercise adequate accountability over matters for which they are individually responsible. A simple majority vote of fifty percent (50%) plus one (1) must be achieved in order to grant membership.

The purpose of HHAP round 5 is organizing and deploying the full array of homelessness programs and resources comprehensively and effectively, and to sustain existing federal, state, and local investments towards long-term sustainability of housing and supportive services. (HSC §§ 50232(a) and 50236(a).)

To accomplish these goals, HHAP-5 requires applicants to apply as part of a region and must be signatory to a Regionally Coordinated Homelessness Action Plan to be considered eligible for HHAP-5 base allocations.

Merced CoC has identified the Collaborative Applicant/Administrative Entity and Merced County as the region for the HHAP-5 application. For purposes of HHAP-5, CallCH defined the term "region" as the geographic area served by a county, including all cities and the CoC or CoCs within it. (HSC § 50230(v)(1).)

Collaborative Applicants will be the signatory Administrative Entity to submit a Regionally Coordinated Homelessness Action Plan that fully complies with HSC section 50233(c). This plan will lay out a strategic approach to address homelessness within the region, emphasizing collaborative efforts among participating applicants. Merced CoC's last Regional Plan was brought forward to the Merced CoC Board on June 02, 2022, for HHAP round 3 laying out Landscape Analysis and Outcome Goals and Strategies for Achieving Those Goals.

Along with this submission, HHAP 5 requires key stakeholders to have an opportunity to contribute their valuable insights and experiences to the plan by opening three public meetings for various groups and individuals, to be hosted by the Collaborative Applicant. The HHAP round 5 also requires a Memorandum of Understanding (MOU) signed by each participating applicant of the Regional Plan.

EXECUTIVE SUMMARY:

The Homeless Housing, Assistance, and Prevention (HHAP) Program is a block grant designed to support regional coordination and to expand or develop local capacity to address immediate homelessness challenges throughout the State of California. HHAP Round 5 grant funding is intended to sustain existing federal, state, and local investments towards long-term sustainability of housing and supportive services. HHAP Round 5 builds upon the investments made in previous rounds of HHAP funding. As with previous HHAP grants, it features broad, flexible use for eligible categories to reduce barriers for entry and increase access to permanent housing and employs an accountability framework through the establishment of specific and measurable performance goals.

On January 12, 2024, the Business, Consumer Services and Housing Agency (BCSH) along with California Interagency Council on Homelessness (CAL ICH) announced that Merced CoC has been allocated a HHAP Round 5 grant, in the amount of \$1,127,384.39. The HHAP 5 application deadline is March 27, 2024.

EXECUTIVE SUMMARY (continued from page 1):

On February 28, 2024, the Collaborative Applicant/Administrative Entity (CA/AE) opened a 72-hour public comment period to the Merced City and County Continuum of Care (Merced CoC) General Membership and Merced CoC Listserv. The 72-hour public comment period closed on March 2, 2024. The CA/AE did not receive any public comments from either the general membership nor members of the public.

Based on the HHAP-5 purpose to "sustain existing federal, state, and local investments towards long-term sustainability of housing and supportive services" the CA/AE is making the following recommendation for consideration:

- Allocate \$612,738.44 to the activity of Operating Subsidies-Interim Housing Operating subsidies may include operating reserves. This total includes the breakdown of activities:
 - \$500,000 to continue operations of existing or new emergency shelters and Navigation Centers 24 hours, 7 days a week, and 365 days a year with associated case management, and
 - \$112,738.44 (mandatory 10% Youth set-aside)
- Allocate \$335,729.05 to the activity Rapid Rehousing to support operating a rapid rehousing type housing service for those experiencing homelessness which is tenant based, time limited, provides permanent housing, and includes wrap-around services.
- Allocate \$100,000 to the activity Systems Support for the homelessness services system infrastructure, regional coordination, and improve accessibility and outcomes.
- Allocate \$78,916.90 to the activity Administrative Costs to the County of Merced as the Collaborative Applicant/Administrative Entity.
