### MINUTES

### I. Call to Order

The regular meeting of the Merced City and County Continuum of Care (CoC) was called to order at 11:05am on September 7, 2023, via Microsoft Teams by Matt Serratto.

#### II. Roll Call

#### V. Consent Agenda Items

Approval sought for this meeting's agenda and August 3, 2023, minutes. Motion from Josh Pedrozo, second from Jennifer Mockus. None opposed. Motion passed unanimously at 11:12 am.

#### VI. Community Projects

#### A. Merced Navigation Center

Jennifer Carr stated the Navigation Center currently housed 65 individuals since opening. Served 739 and currently have 76 participants in the center at full capacity. 19 dogs currently and the CAP is 20.

#### B. Emergency Housing Vouchers

Jesenia Aguilar stated there are currently 55 housed, 9 applications pending approval or denial, 5 pending vouchers, 1 unexpired voucher in hand.

#### C. Distributive Housing

David Carr served 323 people in four (4) Distributive Housing. Housed 46 people. One bed available in Merced and two beds available in Los Banos.

#### D. Homeless Court

19 total graduated. David Carr stated that when someone graduates from the Homeless Court, it means the individual has been approved by the court to get their fines reduced. The graduate also completed many hours of community service to get their fines reduced and the judge grants fine dismissal. That is what is considered a graduate.

#### E. Housing Developments

Maribel Baron stated 1213 V Street project is anticipating a late October opening date with a November 1<sup>st</sup> leasing date. The Developer has already met with 51 individuals to do their intakes. Individuals are a mixture from the Navigation Center, D St. Shelter, and directly off the street. In regard to the units, Behavioral Health and Recovery Services is working with 45 of the units with their clients, 30 individuals through our rapid rehousing (RRH) contract with Healthy House and 5 individuals within the Housing and Disability Advocacy Program. We will be within the 90% occupancy rate and more after. The individual prioritized through this program are through the Coordinated Entry System (CES). All referrals for these units come from CES. The prioritization is first based on the VI-SPDAT score. Pending on that score, you're put into a prioritization list, and then matched with funding. Again, 51 intakes have been completed but that doesn't mean guarantee for the projects, but that means you have been matched up to a funding source and eligibility for prioritization. Intakes will start slowing down to ensure all intakes are not done months in advance of opening and do around five (5) a day compared to the amount they currently conducting daily now. All of the units are at Fair Market Rate (FMR). The units cannot exceed 30% AMI. The clients are not currently receiving income, so we need to match them with Rapid Re-Housing (RRH) funding. BHRS has RRH funding for 45 individuals. After two years we will need to explore other funding sources.

We have been collaborating with the Housing Authority since the application. A developer cannot submit an application to Homekey unless they have collaboration with Housing Authority. Housing Authority is also in attendance in meetings on discussions on how we can make these projects successful and permanent. Housing Authority let us know they will be releasing a request for proposal for project-based vouchers. The goal is to get project-based vouchers to ensure the success of all these projects. The developer is anticipating the proposal to come out and apply for a certain number of vouchers to ensure we can successfully help these individuals, not just for the length of the funding, but for that project-based voucher. The goal is over the next four (4) to five (5) years to make the entire project completely project-based vouchers.

No response yet on the three (3) Homekey applications that were submitted. Shangri-La put in an application for the Motel 6 for 80 units. The City of Los Banos submitted an application for conversion of 60 units motel in Los Banos. 915 Custom Containers submitted proposal for 57 units on Child's Ave for Tiny Homes. All of them were submitted by the July 28<sup>th</sup> date. Anticipated time to hear back from the state is between October and November. There was no definite date provided.

Notice of Funding Opportunity (NOFO) for Fiscal Year (FY) 2023 Recommended Project Applications were brought forward to the Board along with the request for authorization for Collaborative Applicant to submit the CoC application, CoC Planning Grant, and Tiered Applications to HUD via e-snaps portal by September 28, 2023. Motion from Steve Roussos. Second by Josh Pedrozo. None opposed. Vote passed unanimously at 11:41 am.

### X. Collaborative Applicant Information Report Out

- A. NOFO RFP Notice of Funding Opportunity (NOFO) for Fiscal Year (FY) 2023 Continuum of Care Competition and Renewal or Replacement of Youth Homeless Demonstration Program Grants applications have been ranked and completed. Next step, the Collaborative Applicant will be submitting into E-snaps by September 15, 2023.
- B. NOFA RFP 2023 Emergency Solutions Grants Program Balance of State Allocation Notice of Funding Availability is still open until Friday, September 22, 2023. All applications will need to be submitted into eCivis by Monday, October 16, 2023.
- C. Outreach RFP Awardee RFP was launched back in July and received only one application from Turning Point Community Programs. The one application was reviewed and awarded. The award letter has been sent out. Contract negotiations started with Turning Point.
- D. 1213 V St. Rapid Rehousing RFP Awardee- RFP was launched back in July and received only one application from Healthy House Within a Match Coalition. The one application was reviewed and awarded. The award letter has been sent out. Contract negotiations started with Healthy House.

- 1. Christy McCammond shared that HMIS submitted a committee report. The first meeting occurred on April 26, 2023 and the committee meets every two weeks. The committee has committed to reviewing the 2022 Data Standards. Understanding the HUD requirements for data standards. Doing this to better support the HMIS Lead MCCAA. New Data Standards are going to be released for 2024. The committee will be releasing a HMIS charter for review and feedback.
- 2. Iris Gunther-Battles. We have someone from HUD that is a part of the committee which is very helpful.

- 1. Christy McCammond shared that CES committee is an advisory to the CES Lead which is MCCAA. The reports that you will see in October's packet will include a charter. This committee has made recommendations. There are 11 recommendations in total. The advisory committee is ready to support the CES Lead. The last meeting was in August 2023.
- 2. Iris Gunther-Battles shared new training was completed on how to support and prioritize individuals on the CES listing. This is something that we need to look at asap to understand how individuals are being prioritized within the Merced CoC. We would like to make sure that we are not Ad Hocking clients and following the proper prioritization procedure.

  - 1.Lucia Tejeda shared that Youth committee is meeting once per month. Youth met on July 22, and August 25. Discussing reports that we can use to make things better.
  - 2. Jacqueline Villicana We would like to see additional resources for youth. Like the cube, it is a place where Youth can hang around. The Cube has changed into more of an office setting and feels less inviting to the Youth. This committee has questions if individuals are not attending meetings, who do we go about removing member. There is a process to do this within the Governance Charter. The committees are individual entities and can remove individuals, but it has to follow the Charter.

## **EXECUTIVE SUMMARY:**

During the June 2023 Board only meeting, the Continuum of Care (CoC) Board expressed their interest in having the Collaborative Applicant/ Administrative Entity (CA/AE) host a homeless summit. After extensive research, meetings, and evaluations, the CA/AE will be anticipating a summit date of April 2024 for a total cost up to \$16,000. The summit event will be funded with HHAP I & II accrued interests as this event will be hosted for client benefit and would be a great way to bring the community together. Following approval from the CoC Board, the CA/AE will seek out a qualified vendor to contract for services in operations of a summit event.

This summit will focus on the geographical area of the CoC which is Merced County. The goal is to bring together community-based organizations as well as individuals experiencing homelessness to focus on public perception of homelessness as well as how to change that negative perception. Hosting a summit focused on topics that surround homelessness issues in our community, we can prevent and ultimately work together to end homelessness.

- 2) Authorize the Collaborative Applicant on behalf of the Merced City and County Continuum of Care CA-520 to submit the Non-competitive and the Regional Competitive funding applications to HCD via the eCivis portal by October 16, 2023.

## **EXECUTIVE SUMMARY:**

Each year, the Collaborative Applicant (CA), on behalf of the Merced City and County Continuum of Care (CoC), is required to administer the responsibilities for the annual California Department of Housing and Community Development (HUD) funding application. On July 28, 2023, HCD released the 2023 Emergency Solutions Grant (ESG) Program Balance of State (BoS) Allocation Notice of Funding Availability (NOFA) for Non-competitive and Regional Competitive applications. The CoC is responsible for recommending a maximum of two applications for the noncompetitive funding and a maximum of two applications for the regional competition funds.

The CA launched the Merced CoC Request for Proposal (RFP) on August 25, 2023, for both the Non-competitive application in the amount of \$178,825.00 and the Regional Competitive application in the maximum amount of \$1,139,024 for the Central and Imperial Region.

The RFP had a clarification period from August 25th - September 1st and a due date of September 26, 2023. The Scoring Committee reviewed and scored all submitted responses. The CA must provide all scored responses to the Merced CoC Board for review and approval. All applications must be submitted to HCD prior to October 16, 2023, by 3:00 pm PDT.

## **EXECUTIVE SUMMARY:**

The California Racial Equity Action Lab (CA REAL) is a three-year initiative to eliminate racial disparities in community homelessness systems throughout the state of California. Technical Assistance Collaborative (TAC) assists California cities, counties, and Continuums of Care (CoC) in developing racial equity goals and provides intensive support to a smaller cohort of communities. CA REAL fosters transformative learning grounded in racial equity best practice; creates an integrative and transformative space that supports California's Homeless Housing, Assistance, and Prevention Program (HHAP) grantees in translating best practices into action; lifts up community-led racial equity strategies; and promotes collaboration to reduce racial disparities in homelessness systems while centering those who experience the greatest impact.

Each jurisdiction has been tasked by TAC to develop a Racial Equity Improvement Plan. These plans will be presented to the CA REAL team on October 26, 2023, and will begin implementation in November 2023. All goals outlined in the Racial Equity Improvement Plan must be realized by May 2024.
