### ALLOWABLE AMOUNTS FOR NONCOMPETITIVE WITH RAPID REHOUSING SET ASIDE

Street Outreach:	Up to a Maximum of 10% of Total Application Request
Homelessness Prevention:	Up to a Maximum of 10% of Total Application Request
HMIS:	Up to a Maximum of 10% of Total Application Request

### **BoS Competitive Regional Funding**: \$1,139,024 (Central and Imperial Region)

The CoC is responsible for recommending up to two (2) applications for competitive funding.

#### ALLOWABLE AMOUNTS FOR COMPETITIVE REGIONAL COMPETITION

Rapid Rehousing:	\$75,000 - \$200,000 per Application
Emergency Shelter:	\$75,000 - \$200,000 per Application
Street Outreach:	\$75,000 - \$200,000 per Application as a Stand-Alone or 10% of Application with a Maximum of \$20,000 when requested with RRH or ES
Homeless Prevention:	Up to 10% of Application with a Maximum of \$20,000 when requested with RRH or ES. Stand-Alone HP applications are <b>not</b> permitted.
HMIS:	Up to 10% of Application with a Maximum of \$20,000
